1. The tender shall be neatly arranged, plain and intelligible. Each page of the tender should be signed. They should not contain any terms and conditions, printed or otherwise, which are not applicable to the tender. The conditional tender will be summarily rejected. Insertions, postscripts, additions and alterations shall not be recognized, unless confirmed by bidder's signature. Bidders are requested to submit the Technical Bids (Annexure – II) and Financial Bids (Annexure-III) in separate envelopes.
2. The bidders should visit the site before bidding to apprise themselves of the exact requirements relating to the scope of the work.
3. The bidder shall submit documentary evidence in respect of their technical capabilities and experience in providing of similar services.
4. Any tender received by Embassy of India, Rabat after the deadline for submission of tenders will not be accepted/considered.
5. The firms concerned will be fully responsible for the safety and insurance of its employee.
6. In case of any ambiguity/dispute in the interpretation of any of the clauses in this tender document, Embassy of India, Rabat's interpretation of the clauses shall be final and binding on all parties.
7. If any information furnished by the bidder is found incorrect at a later stage, he shall be liable to be debarred from tendering. Embassy reserves the right to verify the particulars furnished by the applicant independently.

## GENERAL CONDITIONS OF CONTRACT

### 1. Prices

- i. Price quoted by the bidder and agreed to by Embassy of India, Rabat shall be considered final and no price escalation will be permitted thereafter.
- ii. Bidders must quote the price in the format given in Contract price schedule at **Annexure-III** of this document.
- iii. All prices are to be quoted in Moroccan Dirhams only.
- iv. Payment of 90% of total amount will be paid after successful completion of order and rest 10% after a period of three months from the date of successful completion of work.

### 2. Taxes and duties: The rates quoted should be inclusive of all taxes.

3. **Force Majure:** Embassy of India, Rabat may consider relaxing the penalty and work requirements, as specified in this document, if and to the extent that, the delay in performance or other failure to perform its obligations under the contract is the result of a Force Majure. Force Majure is defined as an event of effect that cannot reasonably be anticipated such as acts of nature (like earthquake, floods, storms, etc.), acts of states, the direct and indirect consequences of wars (declared or undeclared), hostilities, national emergencies, civil commotion and strikes at successful Bidder's premises.

### 4. Completion of work:

The work is to be completed within fifteen (15 days) after award of the work order. Embassy of India, Rabat reserves the right to levy penalty @0.5% of the contract value per day for delay beyond the scheduled period upto maximum of 5% of total contract value.

5. **Workmanship Guarantee** : The successful bidder should give a workmanship guarantee of 12 months for entire work carried out and manufacturer's guarantee for specific period for equipment installed.

**Annexure-I****SCOPE OF WORK**

Following are the details of work for supply and fixing of PTCC on top of boundary wall at Embassy of India in Rabat at 88, Rue Ouled Tidrarine, Souissi, Rabat:

**1. Minimum specifications:**

S.No.	Parameter	Specifications
1.	Coil Diameter	600mm when placed in position
2.	Weight	Each coil with 50 turns/loops should be around 9-10kgs $\pm$ 5%. If the turns/loops are less, the weight shall be correspondingly less.
3.	Steel Strip	The Punched Tape should be CR3 grade cold reduced low carbon steel with pre-painted aluminium zinc alloy 120.
	<b>Spring Core Wire</b>	
4.	Material	Should be high carbon steel, high tensile steel min tensile strength of 1600 mpa
5.	Diameter	2.6mm – 3mm
6.	Zinc Coating	The core wire should have thickness of hot dipped galvanized zinc to 240g/m <sup>2</sup> (as per specification BS EN ISO 1461)
7.	Expandability	About 6 meters
	<b>Razor Barb</b>	
8.	Length	7-8 mm
9.	Spacing	18-20 mm
10.	Blade Thickness	0.5 mm – 0.7 mm, hardness 137 to 185 viakers (penetration number)
11.	Strip Width	14 - 15 mm
12.	Centre Width	22 - 23 mm
13.	<b>MS Angles size</b>	40x40x5 mm

2. Punched Tape Concertina Coil (PTCC) is to be provided & fixed in position on top of the boundary wall (approx. 95 mtr. long). Concertina coils have to be provided and fixed as running coils above the pillar height (as per the sketch enclosed). Concertina coil shall be fixed to M.S. Angles with the help of u-nails/split pin. 62 sets of angles will be required – 2 angles per section of the wall as shown in the sketch.

3. The MS angles will be welded to the existing grill (wherever possible) & will be painted to match with it. Apart from this, supporting punched tape wire (with same specifications of core-wire and blade strip as in concertina coils) in straight wires is required to be fixed on angles in 3 rows on each side of the angle.

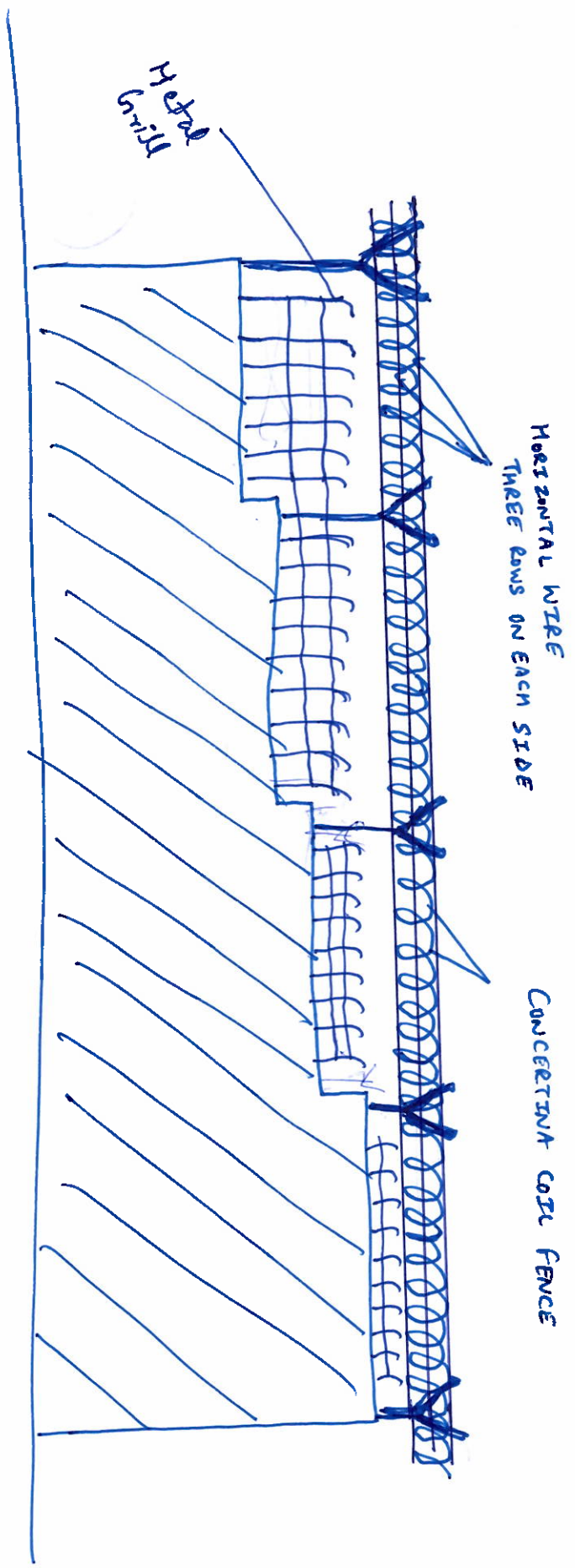
